HOMEOWNER'S GUIDE TO

TAX-DEDUCTIBLE IMPROVEMENTS

BEFORE YOU FILE

Remember to review potential tax law changes impacting homeowner deductions and consult with a tax professional to confirm project eligibility and requirements.



Capital improvement projects

Actions:

- Determine if your project qualifies as a capital improvement.
- Keep records of all qualifying expenses to adjust your home's cost basis.
- Review IRS Publication 523 and Topic No. 701 for details.

Example projects:

- Install a new HVAC system.
- Add attic insulation.
- Build a new deck or patio.



Energy-efficient upgrades

Actions:

- Check eligibility for the Energy Efficiency Home Improvement Credit.
- Understand credit limits for different upgrades.
- Review Notice 2023-59 for details.

Example projects:

- Conduct a home energy audit.
- Upgrade to ENERGY STAR certified windows or doors.
- Install biomass stoves that meet Energy Star requirements.





Clean energy upgrades

Actions:

Review eligibility for the Residential Clean Energy Credit.

Example projects:

- Install a solar water heater.
- Install geothermal heat pumps.
- · Leverage battery storage technology.



Casualty, disaster, and theft losses

Actions:

- Determine if your loss qualifies under IRS Publication 547.
- Calculate the amount of loss via a professional appraisal or through the cost of necessary repairs.

Example projects:

- Repairing your home from fire damage (not arson).
- Repairing roof damage from wind, hail, or falling trees.
- Repairing home damage during a presidentially declared disaster.



Historic home upgrades

Actions:

- Check eligibility for the Rehabilitation Tax Credit.
- Confirm that renovations align with historic preservation standards.

Example projects:

- Upgrade or replace old pipes.
- Replace deteriorated parts to the original standard.
- Home safety upgrades, like new stairs that are up to code.



Medically necessary upgrades

Actions:

- Verify eligibility under <u>IRS Publication 502</u>.
- Determine how improvements impact home value.

Example projects:

- Install systems that can alert those with a disability.
- Grade or level the ground to improve accessibility.
- Add bathroom grab bars or railings to reduce fall risks.



Home office repairs and improvements

Actions:

Confirm that your home office meets <u>IRS requirements</u> for deductions.

Example projects:

- Install a full home security system to protect business assets.
- Repairing damaged outlets and wiring.
- Replace your home office windows.



Rental property repairs

Actions:

- Ensure repair expenses qualify for deductions under <u>Topic No.</u> 414, <u>Topic No. 415</u>, and <u>Publication 527</u>.
- Maintain records of rental-related repair costs and improvements.

Example projects:

- Fix leaks to prevent mold or mildew.
- Address air leaks and update weatherstripping.
- Check and maintain air vents for improved airflow.
